**II. Client Services.** So long as Client is not in default of Client's financial obligations under the terms of this agreement, Client shall be entitled to the following:

**Unlimited Phone Consultations.** As a Client, you can consult with your designated counsel at INVICTUS LAW GROUP, P.L. by phone during regular business hours on any business-related matter.

**In-Office Consultations.** As a Client, you are entitled to 14 in-office consults per year on any business-related matter during regular business hours.

**Discounted Attorney's Fees on Hourly & Flat Fees.** As a Client, if you retain INVICTUS LAW GROUP, P.L. to represent you on any matter on an hourly fee basis, you will receive a 15% discount on all attorney's fees charged and billed and 20% on all applicable flat fees. Your invoices will be calculated by determining the fees for services rendered for the period, less 15%, plus the administrative costs incurred for the period.

**Discounted Attorney's Fees on Contingency Fee Cases.** As a Client, you will not be charged more than 33% of any recovery for attorney's fees on any case INVICTUS LAW GROUP, P.L. represents you on a contingency fee basis.

**III. Fees.** Client agrees to pay INVICTUS LAW GROUP, P.L. the following non refund-able fees for the services outlined above:

**IV. Termination.** This agreement is for one year from the date of execution by Client. This agreement shall automatically renew every year unless Client sends written request for termination. This agreement shall also terminate if a conflict of interest exists between Client and any other Client represented by INVICTUS LAW GROUP, P.L. Upon termination of this agreement, by all benefits shall automatically terminate and if INVICTUS LAW GROUP, P.L. is handling any matters on behalf of Client, all hourly fees shall revert back to INVICTUS LAW GROUP, P.L.'s then normal hourly rate, and all contingency fee

agreements shall revert to the highest rates permitted by law. If termination is due to a conflict of interest, the client will be refunded on a pro rata basis for unused time for the paid period.

**V. Dispute Resolution.** Both Client and INVICTUS LAW GROUP, P.L. agree that any dispute under this Agreement shall be submitted to binding arbitration as provided by any of the applicable rules of the Florida Bar Association or the Orange County Bar Association. Each party shall pay one half of the cost of the arbitrator(s), and shall be responsible for their own attorney's fees and other costs.

**VI. Matters Described.** For the purposes of this agreement, a client "matter" is described as a single issue arising out of a transaction, activity, occurrence, or incident in which the Client is/was involved.

**VII.
